Point Penalties: Hit or step on log, pole, cone, or obstacle Incorrect or break of gait at walk or jog 2 strides or fewer Both feet in space, a skip space, or a split pole/log on the Go-Over obstacle 8 Point Penalties: Break of gait at walk or jog/trot for more than two strides Incorrect lead which is corrected, or break of gait at lope, except when correcting a lead Knock down of obstacle or pole/log Step out or jump off with one foot (after entering) 5 Point Penalties: Step out or jump off with two or more feet (after entering) Dropped object, including gate 1st and 2nd refusal or evasion (each occurrence) On 2nd refusal or evasion - tell contestant to move on Use of either hand to instill fear or praise, touch saddle or horse except for on designated areas when mounting/dismounting Cueing with ends of reins No attempt to fix an incorrect lead Failure to complete obstacle Blatant disobedience (kick, bite, buck, rear, etc.) per occurrence								Judge's Signature: Ribbons: BLUE: Above average, minimal or no mistakes RED: Average, some mistakes WHITE: Below average, needs improvement ORANGE: Disqualification: Break of Pattern (including wrong side of cone) Failed attempts are not broken patterns or disqualifications Eliminating or adding maneuvers Abuse or excessive schooling Equipment failure including a dropped rein Automatic Ribbon Drop: Illegal equipment Failure to have 4-H patch on left arm Failure to wear number Maneuver Scores: Each horse/rider team is scored between 0-100 points and automatically begins the run with a score of 70 points. A score of 70 denotes an average performance.
