#### **Speaker Directory**



**Dr. Aaron Hunt, MPH, PhD**, is an Assistant Professor and Health & Wellness Specialist for Utah State University Extension working to improve outcomes for people impacted by substance use disorders. He earned his PhD in Public Health from the University of Nevada, Las Vegas. His current work is focused on addressing opioid use disorder in rural communities through increasing access to prevention, treatment, and recovery services. He is passionate about reducing stigma related to substance use and promoting the use of harm reduction activities with partners across the state.



Amy de la Garza is a double board-certified Family Medicine and Addiction Medicine physician who has dedicated most of her career to the treatment of individuals with behavioral health diagnoses including substance use disorder. She is an Institute for Functional Medicine Certified Practitioner. She is the owner of Heron Wellness in downtown Salt Lake City, treating patients and families experiencing a broad range of medical and psychiatric diagnoses. Her clinical experiences also include the care of patients in residential and outpatient substance use disorder treatment settings. Dr. de la Garza has worked in both clinical and research environments utilizing innovative approaches to behavioral health treatment including ketamine and psilocybin. She is trained in the 5-Needle Protocol, an ear acupuncture intervention which provides relief for individuals with addiction, trauma and stress.

Dr. de la Garza is the co-founder of Utah Acudetox which provides training and community treatment with the 5-Needle Protocol and the recipient of a SAMSHA grant to expand training and implementation of the protocol across the state of Utah. She is the president of the Utah Society of Addiction Medicine. Her clinical approach is focused on a whole-person, patient directed healing process using evidence-based allopathic medical interventions while simultaneously addressing modifiable lifestyle factors such as nutrition, movement, sleep, stress management and strengthening human connections that are imperative to the healing process. Her vision is the expansion of clinical interventions and research of integrative behavioral health treatment to patients and families that addresses the physical, emotional, and spiritual dimensions of wellness and recovery.

**Dr. Ashley Yaugher** is a Professional Practice Extension Assistant Professor of Health & Wellness at Utah State University Extension. She is a Health Extension: Advocacy, Research & Teaching (HEART) Initiative faculty member and serves Carbon and Emery Counties; with a focus on the opioid overdose epidemic faced by these communities. Dr. Yaugher earned her MS and PhD in Clinical Psychology from Texas A&M University. Dr. Yaugher is currently the Project Director for several substance use prevention and stigma reduction grants; the founder and chair of the local Carbon & Emery Opioid & Substance Use Coalition; and is actively engaged in community-based programming and research. Her professional interests include collaboration; rural mental health; community outreach; mentorship; and Opioid Use Disorder prevention, treatment, and recovery.



**Baylie Cave** is one of the first Certified Peer Support Specialists (CPSS) to work at a federally qualified health care center (FQHC) in Utah. She has been with Carbon Medical Service for about three years and has worked assisting with Covid vaccines and tests, and is a nationally-certified Medical Assistant and Medical Administrative Assistant. Over the last year, Baylie has worked as a CPSS and has been able to help assist with housing, food, medical treatments, and many other tasks throughout her community. Baylie currently lives in Carbon County.



**Benjamin "Ben" Martinez** is a person in long-term recovery and has been since Christmas day 2014. Ben has been a Recovery Coach with his Certified Peer Support Specialist certification since 2016, and came on board with USARA in July of 2018. Starting his substance use disorder and his subsequent recovery relatively young in life, Ben hopes to inspire other young people (and people of all ages) to find the joys, excitement, and full life that recovery offers. Ben is passionate about recovery and uses his story to help others see the potential in themselves to overcome their own barriers in life.









**Cameron Bolman** has over 19 years' experience with the DEA as a Diversion Investigator in auditing, investigating, enforcing, and prosecuting violations of the Controlled Substances Act. Cameron has also had the privilege in serving the community for many years in helping to reduce unwanted and unused prescriptions in the home.



**Cheryl Swapp** is a Community Health Worker at the Sanpete County Jail, through an RCORP grant awarded to Intermountain Healthcare. Cheryl is responsible for helping to bridge the gap between individuals' incarceration and their return into their communities. As part of her daily routine, Cheryl meets with individuals who are incarcerated and together they set goals and create transition plans. After performing an assessment, she helps connect individuals with substance use disorders to counseling classes and long-term or short-term drug and alcohol rehabilitation. When released, she helps connect them with jobs, doctors, therapists, MAT, Medicaid, and helps them obtain any identifying documents. Cheryl works hard to help prepare these individuals for life outside of jail and is pivotal in promoting health equity and addressing health disparities in this population.



**Crystal Randall** began her recovery journey in February 2016. She is a proud graduate of Family and Adult Recovery Courts. She has a passion for women coming into recovery, especially mothers facing the barriers of getting their children back, and for them to know that it is possible and that they don't have to do it alone. Crystal was a peer mentor for the Southwest Behavioral Health Center and Recovery Courts for two years before joining USARA as a Peer Recovery Coach in July 2019.

**Dustin Gillespie** is an Assistant Special Agent in Charge with the Drug Enforcement Administration (DEA). **Elizabeth F. Howell, MD, MS**, has worked in the addictions field since 1983 in public, private and academic settings. She is Professor of Psychiatry (Clinical) at the University of Utah School of Medicine in Salt Lake City, Utah. She has an inpatient and outpatient clinical practice at the Huntsman Mental Health Institute (formerly University Neuropsychiatric Institute) and University of Utah Health. Dr. Howell is Board certified in Psychiatry and Addiction Psychiatry by the American Board of Psychiatry and Neurology, and in Addiction Medicine by the American Board of Preventive Medicine. She is a Distinguished Fellow of the American Society of Addiction Medicine (ASAM) and a Distinguished Life Fellow of the American Psychiatric Association (APA). She developed and is training director for the Addiction Psychiatry and Addiction Medicine

ACGME-accredited fellowship programs at the University of Utah Spencer Fox Eccles School of Medicine.

Dr. Howell has been involved in addiction policy and advocacy at the state and national level for many years. She has been actively involved in the American Society of Addiction Medicine (ASAM) since the mid 1980's, was President of ASAM from 2005-2007 and was recognized with the ASAM Annual Award in 2012. She was President of the Utah Medical Association (2017-2018). She received BS and MS degrees in Zoology from the University of Georgia and MD from the Medical University of South Carolina, Charleston, SC, where she completed a Pediatrics internship, a General Psychiatry residency, and a psychiatry research fellowship and was Chief Resident in Psychiatry.






**Gabriela Murza** received a BS in Psychology and a MS in Health Education and Behavior from the University of Florida. She serves as USU Extension Health and Wellness faculty with the Health Extension: Advocacy, Research, and Teaching (HEART) Initiative, which addresses the opioid overdose crisis and other public health issues through education, collaboration, stigma and harm reduction, and resilience development. Gabi's work focuses on the role healthy eating, physical activity, resiliency skills, and other healthy behaviors play in decreasing injury and chronic pain, and how developing and utilizing those skills can be essential in substance use recovery.



**Haven Halk** is a Family Nurse Practitioner who moved to Utah from Colorado to work at Carbon Medical Service. She has been with CMSA for over five years as a primary care provider and treating substance use disorders. Additionally, she is certified as a Therapeutic Pain Specialist and is trained in Pain Reprocessing Therapy. She evaluates and treats chronic pain conditions, including chronic pain, with an evidence-based approaches focusing on the biopsychosocial model of care, Pain Neuroscience Education, Pain Reprocessing Therapy and teaching self-management techniques. She offers one-on-one Persistent Pain Education sessions.



**Heather Black, PsyD**, is a Clinical Psychologist and current Program Manager of the Salt Lake City Veteran's Affairs Substance Abuse Residential Rehabilitation Program (SARRTP). Heather obtained her undergraduate degree at Cal Poly San Luis Obispo and completed her graduate work at UCLA and Azusa Pacific University. Her life before psychology included working in reality television for MTV and traveling around the world as a photojournalist in active conflict regions. For the past decade, she has served high acuity Veterans in the 15-bed residential substance use disorder treatment program, offering dual diagnosis treatment focuses on assisting Veterans with stabilization and early recovery from severe substance use disorders.

Heather's areas of expertise include interventions treating co-occurring mental health conditions to include PTSD, utilizing evidence-based practices, including CBT-SUD, DBT, ACT- D, IPT-D and MI/MET for SUD, as well as trauma focused interventions PE, CBT and STAIR. In 2020 she became a certified provider of the EAGALA Model, a client-centered, solution-oriented approach to equine assisted psychotherapy that supports interpersonal connections and intrapersonal growth in partnership with clinical team. Additional contributions to the equine community include facilitating hospital-wide integration of the Equine Program and contributing to the gathering and interpretation of clinical data related to both residential and outpatient equine assisted activities, with an outcome of several publications.

**Dr. Ivory Tubbs** is a dedicated clinical expert with a passion for improving the lives of individuals in rural communities affected by substance use disorders (SUD) and opioid use disorders (OUD). Dr. Tubbs also has extensive experience in program development and evaluation, working to make a significant impact in combatting the SUD/OUD epidemic. As a Technical Expert Lead with (WICHE) the Western Interstate Commission for Higher Education, Dr. Tubbs provides technical support to the Health Resources & Services Administration's (HRSA) Rural Communities Opioid Response Program (RCORP). His expertise extends to multi-sector consortiums in rural communities, assisting grantees in planning and implementing their work plans aimed at addressing SUD and OUD.

As an Executive Director of Social Services and later as a Counseling Program Director, Dr. Tubbs demonstrated strong leadership skills by establishing a Rural Center of Excellence for Recovery Housing. His commitment to client care and team development resulted in enhanced program effectiveness. Dr. Tubbs also served as a Psychological Assessor, where he administered diagnostic evaluations and created treatment plans for patients with psychological, behavioral, and co-occurring disorders. He also worked as a Senior Public Health Investigator with the City of Houston, Bureau of Epidemiology conducting psychosocial assessments within the HIV/AIDS community for the Centers for Disease Control. Dr. Tubbs also added to his knowledge base by joining the University of Texas School of Health Sciences, Psychiatric Center working with acute and non-acute psychosis patients as well as patients in the forensic psychology unit for the Houston Police Department.



**Jennifer Liebert** is a Registered Nurse with a Masters in Nursing Education. Her professional focus centers on the addiction field. She is dedicated to helping those battling addiction find their path to recovery and healing.
