# Qualifications

## Age Requirements

Youth must be in grades 3-12 and at least 8 years old by September 1 of the current 4-H year to enroll in the Jr Livestock Program. The 4-H year follows the school year starting on September 1 and ending August 31 of the next year.

## Educational Events

All participants must attend at least two (2) educational events to qualify to show in the Davis County Jr. Livestock Show and Sale.

Educational events include but are not limited to: Davis County Jr. Livestock EDU Nights, EDU nights from other county 4-H livestock programs, IFA, etc.. All educational events must be pre approved by the Jr. Livestock President, President Elect and 4-H Representative via email.

## Ownership of Animals

Participants must own, possess, feed, and care for his/her project animal(s) for no less than 100 consecutive days for market beef and 60 consecutive days for market swine, market lambs, and market goats immediately prior to the show they intend to participate in. **No interruption of ownership or possession can occur.**

## Tagging

- A) All animals must be tagged on the tagging dates offered by the Jr. Livestock Council and Ambassadors. **No house calls will be made.**
  - a) Special arrangements can be made if participants are unable to attend the specified tagging day. If this is needed, reach out to the 4-H Coordinator to schedule a time to tag your animal at the Utah House or Arena.
- B) The Davis County 4-H Jr Livestock Program will follow the Utah State Junior Livestock Association tagging procedure. It is required that all market animal

projects be tagged with a state issued, permanent, tamper-proof tag. The association has uniform tags to be used throughout the state. These tags identify specific animal projects, help track ownership, and are required to participate in any state show. It is the exhibitors responsibility to make sure they have the proper steer, hog, sheep, or goat tag for the show they plan to attend.

- C) Any market animal is only considered eligible for show when an appropriate ear tag has been placed AND tag, exhibitor, animal information has been submitted, along with three (3) pictures, in an online tagging form.
- D) Each participants may tag one (1) extra animal per species for each show period. The alternate animal must be declared as one of the following at the time of tagging.
  - 1. To a specific participant
  - 2. To a family - serves as a “float”
  - 3. To an official chartered club
    - a. An official chartered club must be active in ZSuite. This is done by the club leader turning in a Club Charter Form to the 4-H office. They must also consist of at least one (1) fully registered volunteer, at least five (5) youth members from at least three (3) families.
- E) The 4-H Program Coordinator, FFA advisors, or Species Superintendent ensure animals are tagged and exhibitors are verified and in good standing. Should a tag be lost or pulled out of the animal’s ear, the exhibitor will advise the committee supervisor immediately so the tag can be replaced and the appropriate paperwork can be processed.
- F) Exhibitors are required to cover the cost of the tag per animal. If tags are lost, the exhibitor will be required to cover the cost of the replacements.
- G) All livestock exhibitors must have proof of ownership; cattle must also have a brand inspection; sheep/goats must follow state scrapies tagging laws.
- H) All male animals must be castrated before tagging. Animals who arrive not castrated will not be tagged. Animals that are banded will be able to be tagged.
- I) If an animal has been shown in a market show in-state or out-of-state, it must be shown with the same exhibitor name as in all subsequent shows.

## Behavior

Good sportsmanship must prevail at all times. Participants, parents, guardians, and spectators using foul language or showing lack of respect for judges, show management, or other contestants will be removed from the show and asked to leave.

## Code of Conduct

All Exhibitors, participants, parents, volunteers, spectators, and staff are held to the standards set in the 4-H Code of Conduct. Those found in violation may be subject to removal from any 4-H Jr Livestock event. The 4-H Code of conduct is signed by all youth members and adult volunteers during 4-H enrollment.

## Rule Enforcement

The Jr Livestock Council reserves the right to:

- A) Interpret all livestock rules and regulations for the best interest of the show. The 4-H Jr Livestock Council is composed of those listed under the current years Jr. Livestock Council at the beginning of the rule book.
- B) Dismiss any animals that appear to be unhealthy or pose any undue harm or risk to exhibitors, livestock, or patrons of the show, as well as, animals that do not conform to the rules of the show.
- C) Dismiss any youth participant, parent or spectator for poor sportsmanship towards other youth, adult volunteers, the judge(s), or any members of the Jr. Livestock Council.

## Grievance

All grievances must be made submitted through writing and a twenty-five dollar (\$25.00) fee must be paid on ZSuite. Grievances will be brought to the immediate attention of the Grievance Committee; complainants will not discuss with and/or complain to the judge(s). Grievances regarding the show must be made on the day of the show.

The Grievance Committee will consider the complaint and if found valid will take the necessary action and return the twenty-five dollar (\$25.00) fee via ZSuite.

The Grievance Committee consists of: 4-H Representative, Jr. Livestock Council President, Jr. Livestock Council President-Elect, and Superintendents over the species the participant shows in. The 4-H Representative will only vote to break ties.

**NO SHOW OR GRIEVANCE COMMITTEE MAY ALTER A JUDGE'S PLACING**

## General Rules

The Davis County Jr. Livestock Program will follow the Utah Junior Livestock Association Rules unless otherwise stated in these county rules.

The Utah Junior Livestock Rules are aimed at standardizing junior livestock shows in Utah to provide more uniform shows across the state. Some rules listed may not apply to the Davis County Jr. Livestock Program. The Jr. Livestock Council reserves the right to interpret all livestock rules and regulations for the best interest of our participants and the show.

## Qualification to Show

- A) Youth must be in grades 3-12 and at least 8 years old by September 1 of the current 4-H year to participate in the Jr Livestock Program.
- B) All participants must attend at least two (2) educational events to qualify to show in the Davis County Jr. Livestock Show and Sale.
- C) Participants must be enrolled in the Davis County 4-H Livestock Program through 4H.ZSuite.org by their species tag payment deadline.
- D) Participants must own, possess, feed, and care for his/her project animal(s) for no less than 100 consecutive days for market beef and 60 consecutive days for market swine, market lambs, and market goats immediately prior to the show they intend to participate in. No interruption of ownership or possession can occur.
- E) All participants must be present at weigh in to sell their own animal. If a participant is not present to weigh in their own animal, that animal will be forfeited and will not be exhibited during the market classes or sold through the sale.

## Age Divisions

Age divisions are based upon the participants' grade level as of September 1 of the current 4-H year. No participants may be under 8 years old as of September 1 of the current 4-H year.

- A) Junior: Grades 3-5
- B) Intermediate: Grades 6-8
- C) Senior: Grades 9-12
  - Includes the summer after graduation

## Group Affiliation

- A) All participants must be enrolled in the Davis County 4-H Livestock Program through 4H.ZSuite.org by their species tag payment deadline.
- B) An exhibitor may enter a given show only as a 4-H or FFA member, but not both. Exhibitors must declare one or the other at time of entry.

## Dress Code

Exhibitors who fail to abide by dress standards will be disqualified from the show and forfeit sending animals through the auction. Exhibitors who fail to abide by the dress standards during the auction will be removed from the auction and not allowed to sell animals.

### **4-H -**

A long or short sleeve shirt, which fastens down the front with a collar, is mandatory. Shirts must be solid white in color and need not be Western style. Vests are allowed. Black or blue pants are to be worn. A 4-H patch with the 4-H emblem must be worn on the upper left sleeve. Patches must be visible during the event. No patch or patch not visible is not considered in compliance with 4-H Dress Code. Acceptable patches include any previously manufactured 4-H patch from USU or National 4-H. Embroidered or screen printed 4-H clover emblems are acceptable. Patches are available for purchase through the Davis County 4-H office and at any Davis County Jr. Livestock event. Questions regarding official 4-H dress will be deferred to the 4-H Representative at the show.

### **FFA -**

Either a white shirt, tie and FFA jacket, or a white collared shirt with the FFA emblem and tie.

### **All Participants -**

- A) Leather closed-toed shoes are required for the show and sale ring.
- B) T-shirts, tank tops, tube tops or sleeveless shirts are not allowed.

## Code of Ethics

The Davis County Jr. Livestock Program has adopted the Code of Ethics from the Utah Junior Livestock Association Rules.

- A) The use of any drug, tranquilizer, sedative, or depressant, which alters the psychological or physiological state of the animal, is illegal. See the Utah Junior Livestock Association Rules for more details.
- B) **Lamb Docking Rule** - Scientific research indicates that the incidence of rectal prolapsed is reduced when the tail is docked in a non-extreme manner. The recommended method is to dock at the distal end on the caudal fold (3rd caudal vertebra). Complete tail removal (extreme docking) is not an accepted sheep production practice and is discouraged for all Utah Junior Livestock sheep projects.

- Market lambs or breeding sheep showing any signs of contagious disease or current or recent signs of prolapse, or with an open sore on the dock (rosebud), will be sifted from Utah Junior Livestock Shows at the discretion of the Davis County Jr. Livestock Council at the time of weigh in and their determination is final.
- C) **Drug Withdrawal** - It is unethical and in most cases even unlawful to administer drugs to livestock within 20 to 30 days of slaughter. Animals too unmanageable to show should be withdrawn from their class rather than be tranquilized. The Davis County Jr. Livestock Council and the show veterinarian will monitor this situation. By federal regulations, random testing will occur at slaughter, and animals will be condemned which have been given any injection or oral dosages of tranquilizers, pain killers, antibiotics, diuretics, steroids, or other foreign substances during withdrawal periods before slaughter. All sales money will be withheld in such cases. Bloat medicine and other medications with no withdrawal requirements may be permissible. Exhibitors need to be aware of potential health hazards to consumers who eat animals that have received any above-mentioned substances. Please do not put someone's life in jeopardy.

## Show Entry Forms & Deadlines

Entry Forms for the Davis County Jr. Livestock Show & Sale are electronic and will be collected via 4H.ZSuite.org. Entries are due thirty (30) days prior to the first day of the show unless changed by the Davis County Jr. Livestock Council.

An entry fee\* of ten dollars (\$10.00) per animal will be collected at the time of registration. A fifteen dollar (\$15.00) late fee will be charged per animal for late entries.

*\*entry fees may change with a vote from the Davis County Jr. Livestock Council and depending on sponsorships received by the program.*

## Show Entry Rules

- A) Participants shall enter no more than two (2) lambs, two (2) swine, two (2) goats, and two (2) beef in the market classes. Only one (1) beef can be sold at the auction and no more than three (3) livestock total (any combination) can be sold at the auction.

### **Exceptions:**

1. Participants who have three (3) or more Grand or Reserve Champion animals is to sell all their Grand and Reserve Champion animals
- B) All animals will be inspected and weighed at the time of entry by the Davis County Jr. Livestock Council to uphold the standards of show. Any animal found unsuited for the show will not be exhibited.
- C) All participants **must** show their own registered animal during market and showmanship classes.

**Exceptions:**

1. Participants with physical or mental disabilities who require assistance may be assisted by another participant, parent or member of the Davis County Jr. Livestock Council.
  2. Participants that have two (2) animals of the same species in the same market weight class or star class may have another youth participant show one of their animals until one is dismissed from the class. Once one animal has been dismissed then the participant will finish showing the remaining animal.
- D) All participants must be present at the livestock auction to sell their own animal. **Under no circumstances will substitutions be allowed.** If a participant is not present to show or sell their own animal, that animal will be forfeited and will not be exhibited during the show or sold through the sale.
- E) Youth participants are responsible for walking their animals to and from the stalls for weigh in, showmanship and market classes. Assistance is allowed as needed, the youth participant must remain actively involved in the process.

**Exceptions:**

1. Refer to exceptions from line C
- F) All livestock exhibited in the show must be an official FFA or 4-H project. An FFA Advisor or 4-H Representative must approve entries.
- G) All participants must be in good standing with their group affiliation.

## Stalls

All stalls will be assigned by each species superintendents.

- A) Stalls are required to have sawdust bedding. Sawdust may be provided by the Davis County Jr. Livestock Council or by the exhibitor depending on funding. Committee will give the exhibitors thirty (30) days notice if they need to provide their own.
- B) Participants are responsible for maintaining their stalls during the duration of the show and sale.
- C) Participants who do not clean their stall(s) by the designated time decided by the Davis County Jr. Livestock Council will have fifty (\$50.00) dollars deducted from their check. If they have no sale or boost money, they will be fined with the fifty (\$50.00) dollar fee.

## Weigh In

1. Animals must reach minimum weight in order to show in Market Classes.
  - Market Goats: 50 - 100lbs
  - Market Lambs: 100 -145lbs
  - Market Hogs: 220 - 300 lbs
  - Market Mini Beef: 500 -1000 lbs

- Market Beef: 1000-1300 lbs

There is no upper weight limit for market livestock. Animals that exceed the weight guidelines listed in the rules can still be shown; however, all weight over the maximum amount will be donated to the buyer.

Animals that fall under the minimum weight will be placed in feeder classes.

2. All animals will be inspected and weighed at the time of entry by the livestock committee to uphold the standards of show. Any animal found unsuited for the show will not be exhibited. The Davis County Jr. Livestock Council reserves the right to dismiss any animals that appear to be unhealthy, sick, underweight, or pose any undue harm or risk to other participants, livestock, or patrons of the show, as well as, animals that do not conform to the rules of the show.
3. All participants must be present at weigh in to sell their own animal. If a participant is not present to weigh in their own animal, that animal will be forfeited and will not be exhibited during the market classes or sold through the sale.
4. Early weigh-ins can occur no more than one (1) hour before the scheduled weigh-in occurs. Prior arrangement must be made with the species superintendent. Scale will close at the end of the last species on the weigh-in schedule.
5. Youth participants are responsible for walking their animals to and from the scale for weigh in. Assistance is allowed as needed, the youth participant must remain actively involved in the process. If youth participants cannot handle their own animals and keep them under control then the animal will not be allowed to show or sell.

**Exceptions:**

1. Refer to exceptions from Show Entry Rules, line C

## During Weigh In

1. **Animals will only be weighed once** (Lambs, Goats and Hogs will be weighed without any halters or ropes or blankets on the animal). Steers can be weighed with the halter or rope still on the animal.
2. All ear tags must be clean and visible before entering the scale. If the tag is unreadable the animal must exit the scale and come back before their species is done with weigh in.

## Prior to Weigh In

1. Replacement tags must be in place before weighing in.
2. Market Goats must be clipped to 3/8 inch or shorter to the level of the knees and hocks. Horns must be removed or tipped. **Market Does require scrapies tags at time of weigh in.**
3. Market Lambs must be slick shorn. **Market ewes require a scrapies tag at the time of weigh in.**
4. **Market Beef requires their brand inspection at the time of weigh in.**

## Fitting

The fitting of animals will take place in areas designated by the Arena Manager and the Davis County Jr. Livestock Council. Parents, guardians, siblings, club leaders, Extension/4-H agents and FFA advisors may assist and are encouraged to assist the younger participants. However, each participant must be working with the project animal and be in attendance with that animal during the entire fitting process.

## Davis County Jr. Livestock Show Classes

The following classes will be available for participants in the Davis County Jr. Livestock Program to participate in. If there are no registrations for a class, the class will not happen.

### Showmanship Classes

Showmanship will be held first, followed by the market classes in each species.

- A) Classes will be divided by the age divisions specified by the 4-H program. Depending on size age groups may be split into multiple classes and will require a Star Class.
  - Junior: Grades 3-5
  - Intermediate: Grades 6-8
  - Senior: Grades 9-12
- B) Grand and Reserve Champions will be selected in each age division. All exhibitors will receive a blue, red, or white ribbon at the judges discretion.
- C) Full size and mini beef will be shown in the same showmanship class.

### Market Classes

Market classes will follow each species showmanship classes.

- A) A Market animal includes any animal that is intended for consumption by others and may or may not be sold at the Auction. They can include male or female. Males must be castrated.
- B) Weight classes will be broken by the species supervisor, based on the total number of entries.
- C) If needed, a Star Class will be chosen by the judge from the market classes for selection of Grand and Reserve Champion. All others in the Star Class will be placed by the judge to determine sale order.
- D) If a participant has two (2) animals in the same weight class another 4-H youth can show an animal for someone who has two animals in a weight or star class, they may have another youth participant show one of their animals until one is dismissed from the class.

Once one animal has been dismissed then the participant will finish showing the remaining animal.

- E) To give the youth participants more opportunities to show their animals. Female animals can be shown in both the market and breeding classes.

## Market Goat

Market Goats: 50 - 100lbs

- A) Goats must be under the age of 12 months old.
- B) Horns must be removed or tipped prior to weighing in.
- C) There may be no evidence of breaking of skin or eruption of two permanent front teeth. Milk teeth must be in place.
- D) Market goats must be clipped to 3/8 inch or shorter to the level of the knees and hocks.
- E) **Market does require scrapies tags at time of weigh in.**

## Market Lamb

Market Lambs: 100 -145lb

- A) Lambs must be under the age of 12 months old.
- B) Horns must be removed or tipped prior to weighing in.
- C) Tails must be docked according to the Code of Ethics
- D) Market lambs must be slick shorn prior to weighing in.
- E) **Market ewe lambs require scrapies tags at weigh in.**

## Market Hog

Market Hogs: 220 - 300 lbs

- A) Hogs must be under the age of 12 months old.

## Market Mini Beef

Market Mini Beef: 500 -1000 lbs

- A) Beef must be under the age of 24 months old.

## Market Beef

Market Beef: 1000-1300 lbs

- A) Beef must be under the age of 24 months old

## Feeder Classes

Feeder classes will follow each species market classes.

- A) Feeder classes will consist of any animals that do not reach their species designated minimum weight.
- B) Weight classes will be broken by the species supervisor, based on the total number of entries.
- C) If needed, a Star Class will be chosen by the judge from the market classes for selection of Grand and Reserve Champion. All others in the Star Class will be placed by the judge to determine sale order.
- D) If a participant has two (2) animals in the same weight class another 4-H youth can show an animal for someone who has two animals in a weight or star class, they may have another youth participant show one of their animals until one is dismissed from the class. Once one animal has been dismissed then the participant will finish showing the remaining animal.
- E) To give the youth participants more opportunities to show their animals. Female animals can be shown in both the market and breeding classes.

## Breeding Classes

Exhibitors are encouraged to expand their scope of livestock project experience to include breeding livestock projects. Youth are encouraged to learn and practice raising breeding animals within their clubs and communities.

- A) To give the youth participants more opportunities to show their animals. Female animals can be shown in both the market and breeding classes.
- B) The following classes will be available for participants in the Davis County Jr. Livestock Program to participate in. If there are no registrations for a class, the class will not happen.
  - Beef
    - Heifer/Cow
    - Bull
  - Hog
    - Gilt/Sow
    - Boer
  - Lamb
    - Ewe
    - Ram
  - Goat
    - Doe
    - Buck

- Dairy Goat
  - Dairy goat classes will be a part of the Dairy Goat Show. See Dairy Goat Classes for more information.

## Terms and Conditions of the Sale

- A) Animals must be shown in a market or feeder class to be eligible for the sale.
- B) Youth participants are responsible for walking their animals to and from the sale ring. Assistance is allowed as needed, the youth participant must remain actively involved in the process. If youth participants cannot handle their own animals and keep them under control then the animal will not be allowed to show or sell.

### Exceptions:

1. Refer to exceptions from Show Entry Rules, line C
- C) There will be a 4% commission on all sold animals and boost money.
  - D) Participants are responsible for maintaining their stall(s). Any participant who does not clean their stall(s) at the time designated by the Davis County Jr. Livestock Council will have fifty (\$50.00) dollars deducted from their check. If they have no sale or boost money, they will be fined with the fifty (\$50.00) dollar fee.
  - E) Removal of Animals - Exhibitors who remove animals from the grounds before the release time may be barred from exhibiting at future shows. Removing animals before the scheduled release time will be considered theft.

## Auction

- A) Participants may sell no more than three (3) livestock animals. Only one (1) beef can be sold at the auction per participant.

### Exceptions:

1. Participants who have three (3) or more Grand or Reserve Champion animals is to sell all their Grand and Reserve Champion animals
- B) Grand and Reserve Champions in each division must be sold at the auction.
  - C) Animals shown in the Feeder Classes that are within 5% of the show weight requirements are eligible to go through the auction after all market animals as a feeder animal.
    1. Goats: 47.5lbs
    2. Lambs: 95lbs
    3. Hogs: 209lbs
    4. Mini Beef: 475lbs
    5. Beef: 950lbs
  - D) Once the animal is floored at the sale, it becomes property of the floor buyer.
  - E) All Boost Forms are due the day of the 4-H Junior Livestock Sale.

- F) All proceeds from animals donated to the Jr. Livestock Program and sold through the auction shall be directed solely to the Jr. Livestock Program. If proceeds are designated for a specific purpose (e.g., equipment, infrastructure, or a specific program need), that designation must be declared in writing no later than two (2) weeks prior to the sale date.

## Davis County Jr. Livestock Dairy Goat Show

- A) These classes are open to all purebred goats registered or recorded in the American Goat Society, Canadian Goat Society and the American Dairy Goat Association that are official FFA or 4-H projects.
- B) Davis County 4-H & FFA members who own and/or help care for dairy goats throughout the year may be eligible to enter. Youth who help care for goats for shorter periods of time, which are owned by someone else, are not eligible to participate in the Davis County Jr. Livestock Dairy Goat Show. Record books may be checked. Exhibitors may exhibit animals that are not registered in their name, but the animals must be their project animals with record books kept accordingly.
- C) All registration papers must be checked by the show secretary upon your arrival. If this is not done, those animals whose papers have not been checked will be considered scratched and will not be allowed to show. Getting papers to the show secretary is the responsibility of the exhibitor. Any changes must be done at check-in, not on the day of the show.

### Accepted Breeds

Dairy goats include all recognized American Dairy Goat Association Breeds and include: Alpine, Lamancha, Nigerian Dwarf, Nubian, Oberhasli, Saanene, Sables, and Toggenburgs as well as mixtures of these breeds (aka Recorded Grades). Miniatures of the above breeds will show with their full size counterparts (Miniatures are full sized dairy goats bred with Nigerian Dwarfs only, to create a miniature such as Miniature Alpines, Miniature Nubians, Etc.). Dairy Animals will be shown according to age and breed as need occurs and will be determined by the show committee. Dairy Goats bred with other breeds will be considered meat goats or pet goats based on the breeding and use of the animal.

### Horns

- A) Dairy Breeding Classes: No horns will be allowed. Scurs are allowed if it is obvious that effort has been made to remove or disbud the animal and it provides no harm to the exhibitor, other livestock or patrons of the show.
- B) Boer Breeding Classes: Horns will be allowed on meat goat breeding stock only, both bucks and does.

- C) Market and Pet Classes: must be dehorned or horns must be tipped.
- D) Working Class: Horns will be allowed

## Dairy Goat Show Classes

### Showmanship Classes

- A) Classes will be divided by the age divisions specified by the 4-H program. Depending on size age groups may be split into multiple classes and will require a Star Class.
  - Junior: Grades 3-5
  - Intermediate: Grades 6-8
  - Senior: Grades 9-12
- B) Grand and Reserve Champions will be selected in each age division. All exhibitors will receive a blue, red, or white ribbon at the judges discretion.

### Breeding Classes

- A) Junior Dairy Does

The top 2 placings from each class will return for a Grand and Reserve Champion class.

  - Junior kids born May – August
  - Intermediate kids born March and April
  - Senior kids born September-February
  - Dry Yearlings
- B) Senior Dairy Does

The top 2 placings from each class will return for a Grand and Reserve Champion class.

  - Does under 2 years old
  - Does 2 years old and under 4 years old
  - Does 4 years old and under 6 years old
  - Does 6 years old and older

### Working Pack Goat Classes

Working Class animals include any goat of any age that has been raised and trained for work such as; pack and cart animals. They can be of any breed and will be shown by age. Animals will be judged by ability with some consideration taken for age and maturity of the animal. Points will be awarded properly wearing a saddle at age 4.

- A) Under 4 Years Old
- B) Over 4 Years Old

## Pet Goat/All Other Breeds (AOB) Classes

The top 2 placings from each class will return for a Grand and Reserve Championship class

- Under 1 year old
- 1 year old to under 2 years old
- Over 2 years old

### **Pet Goat/AOB Class Rules**

- A) Pet Goats include any goat that is kept entirely for pleasure and is not used for the production of milk, meat or packing and may include does and wethers. Pet classes will be shown by age with no distinction between breeds unless need arises, which will be determined by the Davis County Jr. Livestock Council
- B) Pet Goats may not be shown in any breeding or market classes. If Pet Goats are shown in a breeding class they will be disqualified from the pet class.
- C) Exhibitors will be allowed to use halters or collars in the show ring.
- D) All animals participating in the Davis County Jr. Livestock Dairy Show must be either tagged or identified by permanent identification. The show committee reserves the right to randomly check and compare the tag or tattoo numbers of any animal with entry, to prove ownership and or correctness of entry information.
