

Food \$ense eligibility waiver

Note to NEA: This form must be used for ALL category 3 audiences, no exceptions. The waiver is good for the undersigned group/location for one fiscal year after which it must be renewed. Send one copy to the state office and keep one copy in the county office for your records.

Locations that qualify and DO NOT require a waiver: (State has one).

- Baby Your Baby.
- Head Start/Migrant Head Start.
- Schools with >50% eligible for free/reduced lunch.
- Neighborhoods and other locations within the boundaries of schools with >50% eligible for free/reduced lunch and/or within census tracts or city boundaries where >50% eligible for SNAP-Ed.
- A qualifying grocery store (redeems >\$50,000 in SNAP benefits redemption monthly).
- Farmer’s markets that have the Electronic Benefits Transfer (EBT) option.

Locations that likely qualify, but MAY REQUIRE a waiver:

- Deseret Industries.
- Senior Citizens centers (as eligible).
- Schools with 45-50% eligible for free/reduced lunch.

Locations that DO NOT need a waiver:

- SNAP participants
- DWS offices
- FDPiR participants
- Food pantries/banks or DROPS services
- Soup kitchens
- Medicaid recipients
- TANF (welfare) recipients
- WIC
- Public (HUD) housing
