### Jake Franke, Franke Cattle, Cisco, TX

Jake coached the Texas A&M Livestock Judging Team from 2009-2012 and 2004 -2007. He was named the Intercollegiate Coach of the Year in 2010 and 2006. Jake coached the National Champion team in 2006 and was the Assistant coach for the 2004 National Champion team.

He has judged major livestock shows in Louisville, KY, Denver, CO, Tulsa, OK, Houston, TX, San Antonio, TX, Ft. Worth, TX, Dallas, TX, Phoenix, AZ, Jackson, MS, Perry, GA and Lawton, OK. He has also judged many regional and county fairs around the country.

Jake is the Program Manager of the Premium Nutrition Network for Anipro/Xtraformance Feeds, XF Enterprises, where he manages a national value-added cow-calf and stocker supply chain program. He accomplishes this by providing support to the company's regional and district managers with implementing the nutrition and health requirements of the company's program into their customers' operations while coordinating those calf crops to various feedyards, backgrounding operations and cattle brokers/order buyers

Jake received his Ph.D., M.S. and B.S. Degrees from Texas A & M University. He and his wife Jaimie, own Franke Cattle Company in Cisco, Texas where they raise and sell club calves and replacement heifers. They have raised 50 major show breed champions, numerous county fair champions and 4 overall grand champions at major shows.
