**Information Presented**

Dixie presented an update of BLM applications for approval to drill. She didn't know how many of these were in sage-grouse habitat, but they are mapped—both potential sites and existing wells.

Brian gave an update on West Nile Virus. The grouse that was found was in Arcadia and was found in a corn field. She was an adult female that did have a brood. The people that found the bird claimed that there are 30-40 birds in that area and they were able to point out a potential lek site. Some sage-grouse do survive WNV, but most die and die quickly. The bird found here was very thin and undernourished. So far, this is the only sage-grouse found so far in the state.

15-16 grouse are still collared on Anthro Mtn. DWR plans to fly through the winter to see where those birds go. Right now, there is no information about where those birds go. Lots of DWR

projects going on right now or will be soon; update on this next time.

Scott reported that last month they had a field tour with several agencies on Blue Mountain to consider habitat projects. Dixie reported that the BLM is looking to treat the entire Mountain and they will be looking at that in the field tomorrow.

Sarah informed the group that the MOU was being re-worked by folks with the NRCS and wouldn't be ready until October or November. Signature gathering was postponed until further notice.

## **Discussion Highlights**

Group discussed Conservation Targets table and worked on Indicator Ratings for Population Size. Group reached consensus on numbers for males on leks and number of active leks (see table).
